Confirmation of Minutes: Minutes of the March 2017 meeting having previously been circulated, were agreed by all Cllrs at this evenings meeting as a True Record and Signed by The Chairman.

Declaration of Members Interest: There were none

Public Participation:

April Gates enquired reference the Floral Baskets and planting of the Concrete Tubs for 2017 to which The Chairman gave a very informative reply. The Chairman also paid special thanks to April and Liz for their continued contribution in planting and maintaining the concrete tubs adjacent Gull Court. Thanks were also paid to Parkers Nurseries who kindly donate the flowers to plant in the pots.

Alan Newman commented as follows: Work carried out to the wall on the bridge at Holland Brook looks hideous and it was sheer nonsense that it was done for safety reasons. Alan said he could not remember there ever being any accident there.

As the Allotment Site development has now started, could a request be made to the developers for each allotment site to have its own 6 x 4 shed with running water and taps readily available. When asked, the Chairman said that the allotments will be handed over to The Parish Council who would be the body to allocate them.

Whilst discussing the allotments Cllr Fielder enquired what the actual boundary was regarding the ditch on the allotment site and the boundary of his land. Roger said it is usually a Common Law that is normally surveyed and goes from the centre of the ditch. It is up to residents to police the matter themselves and come to a constructive agreement with the contractors. A further option would be to contact your solicitors.

Roger Hawes expressed his concern reference the proposed closure of Ticket Offices at 6 of the 7 Stations in Tendring with Thorpe being a station that will be affected.

The Clerk said she was aware of the proposal and a letter was sent on the 10th March.

- 1 Urbanisation of the site which currently acts a green buffer
- **2** Access opposite Golden Lane entrance and onto the very busy Colchester Road.
- **3** Outside the village settlement development boundary.
